In fulfilling its charge as established in the by-laws of the Berkeley Division of the Academic Senate, the Committee on Faculty Awards (FAC) carried out the following actions and activities in 2015-16.

DIVISIONAL AWARDS

Edward A. Dickson Emeriti Professorship

- The Dickson Emeriti Professorship recognizes emeriti for teaching, research, or public service. In 2015-16, the Edward A. Dickson Emeriti Professorships nominations were approved: Professor Emeritus Joel Altman, (English) and Professor Emeritus Carlos Muñoz Jr. (Ethnic Studies).
- Nominations were solicited for 2016-17 and approved for: Professor Emeritus John Casida (Environmental Science, Policy, and Management, and Nutritional Science and Toxicology) and Professor Emeritus Jack Kirsch (Molecular and Cell Biology). (9/9/15, 2/1/16)

2016 Clark Kerr Award

The Clark Kerr Award for Distinguished Leadership in Higher Education recognizes an individual who has made an extraordinary and distinguished contribution to the advancement of higher education. George Breslauer, faculty director of The Magnes Collection of Jewish Art and Life, Professor of the Graduate School in The Charles and Louise Travers Department of Political Science, and Berkeley's executive vice chancellor and provost, emeritus, was recommended to Divisional Council, and approved on November 2, 2015. Berkeley Faculty Service Award

- A fall ceremony was held for the 2015 Berkeley Faculty Service Award.
- The committee solicited nominations and forwarded two recommendations to Divisional Council for the 2016 award. Constantine Panunzio Distinguished Emeriti Award

The Panunzio Distinguished Emeriti Award honors emeriti in the humanities or social sciences who have performed outstanding scholarly work or educational service since retirement.
