- V. NEW BUSINESS
  - **A. Discussion/action:** Systemwide Review of Proposed Presidential Policy on Dual Use Research of Concern and Pathogens with Enhanced Pandemic Potential

**B. Discussion/action:** Systemwide Review of Proposed Revisions to Academic Personnel Manual (APM) Section 675, Veterinary Medicine Salary Administration

The commenting committees stated brief comments and expressed support for the proposed revisions. The revisions were said to be a rational way to think about how it might engage with the Negotiated Salary Program.

**ACTION:** DIVCO authorized Chair Nuru-Jeter to draft a letter forwarding committee comments to the Chair of Academic Council.

C. Discussion/action: UC San Francisco (UCSF) Memorial Vote

Vice Chair Stacey presented an informational slide deck on the proposed Memorials from the San Francisco Division created by Chair Nuru-Jeter outlining the Memorials, relevant arguments, and overall timeline of the Memorial process. DIVCO members engaged in a discussion covering points presented by the commenting committees. After discussion, a vote was held on each Memorial. Both Memorials were opposed.

DIVCO continued to discuss several concerns which included, among other things, inequities experienced by various groups of faculty (i.e., Health Sciences Clinical, Adjuncts, Lecturers, and Cooperative Extension Specialists) such as exclusion from decision-making from and providing a voice on matters that impact their welfare as Berkeley faculty. A related question was posed as to whether there is the potential for improved use of the in-residence faculty series or other policies that may better support these faculty groups. DIVCO members contemplated creating one or more ad hoc committees with representation from various constituencies to address these issues.

**ACTION:** DIVCO authorized Chair Nuru-Jeter to draft a letter forwarding the vote results to the Chair of the Academic Council.
