2017-18 Annual Report of the Committee on Courses of Instruction

In fulfilling its charge as established in the Bylaws for the Berkeley Division of the Academic Senate, the COCI carried out the following activities during the 2017-18 academic year. Professor Robert Ashmore (East Asian Languages) served as chair.

I. Actions on Course and Instructor Approvals, Variance Requests, Degree Conferrals, and Course Codes

- **A.** Reviewed and approved 676 changes to campus courses, including new offerings and modifications. As authorized by COCI, Senate staff approved another 377 proposals for minor modifications and withdrawals. In total, 1051 courses and modifications were approved.
- **B.** Reviewed and approved 8 new UCB Extension courses (with instructors), and 99 new instructor/course pairings.
- **C.** Reviewed 67 variance requests (64 approved, 3 denied), including 11 Acting Instructor-Graduate Student requests and 2 grade grievances.
- **D.** Reviewed approximately 304 student-facilitated course proposals (spring and fall 2018).
- **E.** Conferred degrees and honors on behalf of the Academic Senate for summer 2017, fall 2017, and spring 2018.
- **F.** Approved the creation of the following new course codes:
 - CYBER Master's degree program in Information and Cybersecurity
 - DIGHUM Summer certificate program in Digital Humanities
 - HUM To support interdisciplinary "Compass Courses" from the Division of Arts and Humanities
 - RDEV Master's degree program in Real Estate Development + Design
 - SSEASN, SASIAN, HINDI, URDU, and INDONES To replace current codes used for Bachelor of Arts in South and Southeast Asian Studies

- Guideline for Undergraduate Pedagogy Courses (for Undergraduate Teaching Assistants): Across summer and fall 2017 members discussed the use of undergraduate students as teaching assistants and the awarding of academic credit for students engaged in such activities. Discussion across the fall semester included consultation with multiple campus experts including L&S Dean Bob Jacobsen, L&S Coordinator Susan Cass, Center for Teaching and Learning Director Richard Freishtat, and Labor Relations Advocate Deborah Cohen As a result members added to the COCI Handbook section 2.8 which sets forth review guidelines (final approval 12/08/17).
- Online Course Re-Review: COCI reviewed nine online courses that were originally approved in 2013-14. This year review was conducted by utilizing an online form service so to gather quantitative data on the implementation and feedback of these courses. This new data collection method resulted in COCI generating a best practices style document for future online courses (final discussion 04/13/18).
