BERKELEY DIVISION OF THE ACADEMIC SENATE Committee on Research 2017-18 ANNUAL REPORT - APPROVED

This report summarizes the activities of the Committee on Research (COR) for 2017-18. The committee continued its work in the absence of a permanent Vice Chancellor for Research (VCR) during the fall semester.

RESEARCH AND SCHOLARSHIP GRANTS

Under a three-year extension of the agreement reached with the Executive Vice Chancellor & Provost (EVCP) in 2014, COR received its allocation of \$50,000 to offer emeritus faculty a basic level of research and conference travel support. Emeritus faculty with a funded research program or proceeds from an endowed chair exceeding \$10,000, or other sources of funds to support their proposed research, were ineligible to apply for a grant. The committee instituted this restriction to direct its limited funding to those emeriti who otherwise would have little or no support. This year, 78 emeriti each received an award of \$640, down from 93 emeriti in 2016-17. Funding for the emeritus grants will continue until at least 2019-20.

ORGANIZED RESEARCH UNITS (ORUs)

Due to the continuing transition in research leadership on campus, ORU reviews continued to be suspended for the year. At its meetings with the interim Vice Chancellor-Research in the fall and with the new VC-Research in the spring, the committee expressed its concerns about the ongoing suspension of ORU reviews and encouraged leadership to resume them as soon as possible.
