III. ANNOUNCEMENTS

Chair Max Auffhammer

Chair Auffhammer reiterated his plans from last week regarding the 299 syllabi. He had received syllabi from the Psychology and Public Health departments and reworked them into a generic sample. He will be meeting with the Committee on Courses of Instruction (COCI) to review the sample prior to having the systemwide Academic Senate and the Employee and Labor Relations (ELR) review it. If departments have questions, they should be directed to Chair Auffhammer or the Chair of COCI.

Chair Auffhammer stated the results of the University's branding exercise. Athletics, then referred to as "Cal" is recommended to be rebranded as "Cal Berkeley." Anything that is not athletics is recommended to be referred to as "Berkeley."

Chair Auffhammer provided an update that there is a new form for regular merit reviews. The campus will be using this method moving forward.

Finally, Chair Auffhammer described that there have been numerous conversations centered around Intercollegiate Athletics (IA). He asked that DIVCO members think about the implications of the new conference membership, and what it means for athletes' travel, classroom success, and academic expectations. Chair Auffhammer will be working with the Chancellor's office and IA leadership on creating a two-page fact sheet

about IA. DIVCO members questioned the goal for these conversations.

V. NEW BUSINESS

A. **Discussion only:** Graduate Education

Guest: Lisa García-Bedolla, Vice Provost for Graduate Studies and Dean of the Graduate Division

Vice Provost García-Bedolla thanked the DIVCO members for their service. She acknowledged that over the last four years, much work was done to keep Berkeley afloat, especially during the pandemic.

Vice Provost García-Bedolla shared new metrics regarding this years' cohorts, Ph.D. programs, and graduate education. She explained that there were various departments with increases and declines in enrollment following the strike, but graduate enrollments have consistent with pre-pandemic trends. Top reasons for declining acceptances include academic fit and funding.

Vice Provost García-Bedolla stated that there are challenges with the implementation of the 299 syllabi efforts and rebuilding relationships. UC Employee Labor Relations (ELR) is understaffed which makes it difficult to get answers in a timely manner.

Discussion followed, and there was a comment opposing the *Conflict of Attestation* policy since it creates more burden. DIVCO members commented on the process and policy, and others provided suggestions to the process. The main reason for this policy is to avoid legal repercussions when considering admissions.

B. **Discussion only:** Graduate education—Framing Academic Senate "Study"

Chair Auffhammer asked DIVCO members to think about what aspects related to graduate education they are worried about in their respective fields in the next five years. Some of these concerns included:

- The shrinking graduate student populations and how it affects being able to have Graduate Student Instructors (GSIs) teach classes. The bottleneck is the number of GSIs as a resource issue.
- Issues surrounding rules and resources with respect to DSP.

DIVCO members revisited the conflict-of-interest policy and how it affects the bureaucratic burden on departments. Members sympathized with those departments that were heavily burdened by this policy. One member believed that this policy should have the university set a strategic direction, instead of being directed by legal advice.
