**ACTION:** The conflict of interest policy for DIVCO 2018-19 was approved.

### **B.** Divisional priorities for 2018-19

Division Chair Spackman named several of her priorities for the year:

- DIVCO review of the Berkeley Strategic Plan by October 15: Relevant Senate committees were asked to review the strategic plan reports with respect to their purviews, to comment on their priorities, and to provide feedback on implementation. Because some members of CAPRA were already involved in the Financial Strategies Working Group, two elected members were asked to review that group's report.
- Senate input in the development of micro-degrees; a task force will be formed to consider this degree format.
- Senate involvement in faculty growth and the role of comprehensive academic excellence.
- Retiree health benefits.
- Administrative staffing levels: The Committee on Academic Planning and Resource Allocation (CAPRA) will continue to follow this issue.
- Graduate student support.

Other issues of concern, including some raised during the Senate orientation last week, included:

- Resource considerations for Disabled Students' Program accommodations.
- Self-supporting graduate professional degree programs.
- Faculty housing.
- Staffing for courses: decreasing graduate student instructors, increasing section sizes, and the use of undergraduate teaching assistants.
- Admissions: transfer guarantee for community college students, compound bachelor's/master's degrees, and the use of standardized testing.
- Contingency budget planning.
- Student housing.
- Student mental health.
- Emeriti welfare.
- Proposed changes in degree requirements.
- Strengthening diversity efforts in planning and new degree proposals.

**ACTION:** The Committee on Diversity, Equity, and Campus Climate was charged to draft a diversity statement for such purposes.

- Regionalization of research administration.
- Senate representation in the search for a new graduate dean.
- Follow up to the report of the Commission on Free Speech.
