V. NEW BUSINESS

A. North Campus Facilities Renewal

Rosemarie Rae, Vice Chancellor of Finance/Chief Financial Officer (VCF)

Chris Yetter, Senior Advisor to the EVCP

EVCP Alivisatos, VPAP Alvarez-Cohen, AVC Arvin, and VCF Rae, presented an update on campus planning, specifically regarding the northeast campus quadrant. A high priority is placed on Evans Hall due to the extremely poor seismic rating and high occupancy. Funding and the availability of surge space are important for the capital projects.

Changes to the planning process include the solicitation of campus consultation at key decision points. The report of the Senate-Administration Working Group on the Upper Hearst Project is expected this year and will include recommendations for three new committees, focused on programming, finance, and technical review. The Senate's

input to the administration on the Senate's academic priorities and academic principles would be helpful.

Key points raised in the open discussion included the following:

- The Senate should be consulted early in the planning process, particularly the Committee on Academic Planning and Resource Allocation (CAPRA).
- Transparency is important to building an effective partnership between the Senate and the administration.
- The pro forma developed last summer by faculty experts should be utilized.
- Discipline is not a determining factor in decisions about which buildings will be replaced or retrofitted.
- New buildings will include classroom space.
- One member requested the campus policy on the naming of buildings for companies.

ACTION: VCF Rae will forward the naming policy to DIVCO.

ACTION: A subgroup of DIVCO will be formed to draft recommendations on the Senate's academic priorities and principles for consideration at the next DIVCO meeting. Members were asked to provide suggestions.

ACTION: CAPRA is to present recommendations for improving the planning process.
