In fulfilling its charge as established in the by-laws of the Berkeley Division of the Academic Senate, the Committee on Faculty Awards (FAC) carried out the following actions and activities in 2017-18.

DIVISIONAL AWARDS

Edward A. Dickson Emeriti Professorship

The Dickson Emeriti Professorship recognizes emeriti for teaching, research, or public service. The committee submitted two nominations for the Edward A. Dickson Emeriti Professorships this year which were approved: Jan de Vries, Ehrman Professor Emeritus (History), and Christina Maslach, Professor of the Graduate School (Psychology). (2/5/18)

Clark Kerr Award

The Clark Kerr Award for Distinguished Leadership in Higher Education recognizes individuals who have made extraordinary and distinguished contributions to the advancement of higher education.

A private dinner was held on December 5, 2017, to present the 2017 Clark Kerr Award to Professor Mary Sue Coleman, president of the Association of American Universities.

The committee made two nominations for the 2018 Clark Kerr Award. The nominations of UC President Emeritus Richard C. Atkinson and Provost Emeritus C. Judson King III were approved by Divisional Council on May 7, 2018. (2/5/18)

Berkeley Faculty Service Award

The committee nominated J. Keith Gillless (Environmental Science, Policy, and Management, and Agricultural and Resource Economics) and Robert L. Powell (Political Science) for the 2018 Berkeley Faculty Service Award. (10/16/17) The nominations were approved by Divisional Council on 12/11/17, and awards presented at a reception on May 9, 2018.

Constantine Panunzio Distinguished Emeriti Award

The Panunzio Distinguished Emeriti Award honors emeriti in the humanities or social sciences who have performed outstanding scholarly work or educational service since retirement. FAC made a divisional nomination for this systemwide award to the selection committee at the University of California, Los Angeles. (2/5/18)
