Committee on the Library

2021-2022 Annual Report

In fulfilling its charge as established in the Bylaws of the Berkeley Division of the Academic Senate, the Library Committee carried out the following activities. The chair of the Library Committee during the 2021-22 academic year was Professor Daniel F. Melia.

Chair's Summary:

The explicit aims of the Library Committee in 2021-22 were:

- 1. Establishing a multi-year vision for the Library, taking account of the changing landscape of services it is expected to provide.
- 2. Ensuring that the Library has adequate space, resources and personnel to remain one of the pre-eminent libraries in the world.

The September meeting was held in person with some members joining via Zoom. Owing to Covid-19 restrictions, all subsequent meetings were held remotely via Zoom.

The year began with the proposed library budget already showing strain. The budget could only be balanced by exhausting the last of the monetary reserves. The committee expressed concern about closures of smaller libraries, but even more about reduction in acquisitions. In October, LIBR created a subcommittee to evaluate developments since the 2013 report on The Future of the Library, chaired by Professor Van Houweling and including Professor Sposito, both of whom had served on the 2013 task force.

The November meeting concerned itself with the Library's response to the student demonstration regarding the exhibit of library holdings regarding the Philippines. The exhibit reflected the history of the library's holdings in Asian areas which unsurprisingly reflected the colonialist views of many early twentieth century politicians and academics. The Library intends to provide more context in future exhibits (which will be less numerous owing to budget cuts.) The committee also advised the Library on revised advertising for the position of Director of the Bancroft Library/Associate Librarian for Special Collections. The committee urged additional efforts to recruit a well-qualified scholar, though acknowledging that that might be a difficult task.

There were continuing discussions of consolidation of specialty libraries and the damage to research and teaching resulting from the reduction in resources for each of the library's main tasks: Archiving, Acquisition, and Access. These concerns were echoed by the report of the subcommittee on the Future of the Library, which urged direct contact with higher administrators. The committee viewed the steady reduction in the library's budget as essential business for the committee in the coming year.
