With the PG&E power outage and its aftereffects, it's been quite a fortnight on campus! At the debriefings that occurred last week, many people expressed profound gratitude to the staff for their extraordinary work during the outage. We, too, are grateful to the staff, and also to Division Secretary J. Keith Gilless who generously served on the campus's Crisis Management Team on behalf of the Senate during the outage. The Senate is fortunate to have a member with Keith's expertise. For the Senate, the outage revealed the urgency of making our courses more resilient to interruptions of different kinds. These meetings are an important opportunity for Senate faculty to participate in the governance of the university. Please make it a priority to attend. Your Divisional Council met for the fourth time of the fall on Monday, October 21st. Much of the meeting was devoted to the topic of capital planning. As we have shared before, campus is about to enter a phase in which an unusually large number of buildings will be built or retrofit and renovated. DIVCO shares with the administration a commitment that this process be as effective as possible. To that end, DIVCO has developed a set of advisory principles for decision-making regarding capital projects, which were discussed and will be posted on the Senate webpage when approved.

We also had a second conversation with Vice Provost for Academic Planning Lisa Alvarez-Cohen and Vice Chancellor of Finance-Chief Financial Officer Rosemarie Rae about the newly-developed process for the approval of specific capital projects. At the heart of this new process are three parallel parts, each with Senate representation: a finance committee, an academic programming committee, and a set of technical reviews. The Capital Projects Finance Committee will be a standing committee, with Senate members appointed by COMS serving alongside representatives of the administration. It will be charged with conducting comparative analyses of the financial implications of different potential campus projects. The technical review is already in place, and consists of seismic-, design-, and sustainability reviews. Academic Program Committees, in contrast to the others, will be ad hoc committees appointed for each specific project, to ensure that there is relevant local expertise about the kinds of scholarly and pedagogical work that each project will enable. DIVCO felt that this new process is robust, with a considerable role for Senate participation, and looks forward to seeing it in action in upcoming capital projects.

DIVCO then discussed the Academic Program Review of the German Department. Academic Program Review is a critical part of ensuring the comprehensive excellence of our university. In collaboration with the vice provost for academic planning, the Senate generally conducts 6 to 8 such reviews every year, ensuring that all departments and schools are reviewed at least once every 10 years. These reviews should provide guidance both for departments and for the administration about how to sustain and extend scholarly and pedagogical excellence.

Our final topic this week at DIVCO concerned Unit 18 lecturers. The Committee on Academic Planning and Resource Allocation brought forward a statement recognizing the important work that lecturers do, now teaching over 40% of the student credit hours on campus. DIVCO discussed this statement, and will take it up again at our next meeting.
