The second meeting of DIVCO was held on Monday, September 24. Among the issues discussed were the joint statement by CUCFA and CA-AAUP on academic freedom for UC librarians and a proposed task force on “micro-degrees” and EdX course offerings by Berkeley faculty. The following three proposed policies were also forwarded to various committees for their commentary and analyses:

1. Proposed Presidential Policy entitled, “Principles of Accountability with Respect to Financial Transactions.”
2. Proposed Presidential Policy entitled, “Proposed Revised Presidential Policy on Sexual Violence and Sexual Harassment

3. Proposed Presidential Policy entitled, “Proposed revisions to Presidential Policy BFB-RMP-7 Protection of Administrative Records Containing Personally Identifiable Information.”
